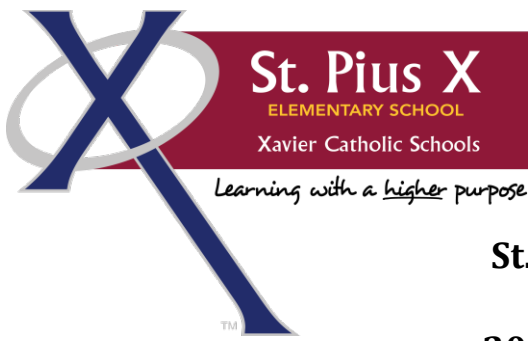

Please fill out the attached application for our Enrichment Program. Completed applications should be returned to the ELC no later than January 17, 2020. You will be notified by January 24, 2020 of your status for enrollment. Upon approval of your application, a non-refundable registration fee and a \$30 activity fee will be collected. This will be due no later than January 31, 2020.

Final registration dates will be on May 12 and May 14, 2020. At that time you will be required to complete enrollment paperwork and pay a deposit equaling your first month's tuition—first 2 weeks for those doing Enrichment with Before/After Care. This non-refundable deposit will secure your enrollment for the 2020-21 school year at the St. Pius X Early Learning Center.

**Tuition Options:**

- Annual Payment: Due September 15<sup>th</sup>, 2020
  - Semi-Annual: Due September 15, 2020 & January 15, 2021
  - Monthly EFT Payments (10 months): Due 15<sup>th</sup> each month
- \*A lunch and a snack will be provided for all Enrichment children daily*  
*\*Breakfast will be provided for those enrolled in before care*
